Based on the legal reason stated in article 5 of the law, "being clearly stipulated by the law, necessary for the establishment and execution of the contract and fulfilling the legal obligation" invoice, payment, logistics; And based on the legal reason for "obtaining explicit consent", order transactions, promotion, reputation management, customer satisfaction transactions. The personal data in these transactions are obtained verbally, in writing or electronically, are processed completely or partially automatically, and are protected by taking all necessary technical and administrative measures. In transactions based on explicit consent, if the explicit consent is withdrawn, data processing activity will be stopped.

Personal data are shared with real persons or private law legal entities, shareholders, suppliers, authorized public institutions and organizations, private insurance companies, contracted services, and cooperating companies, limited to the realization of the above-mentioned purposes.
